KRBE'S "MASKED SINGER" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KRBE ("Station"), 9801 Westheimer Rd., Suite 700, Houston, TX 77042, during available business hours Monday through Friday, on the Station website www.krbe.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **KRBE's "MASKED SINGER"** contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 90 days or a prize valued at \$500 or more in the last 180 days or a prize valued at \$500 or more in the last or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 90 days or a prize valued at \$500 or more in the last 180 days. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

Contest Period. The Contest entry period will begin at 6:00 am CT on Tuesday September 24th, 2024 and will run weekdays from 6:00 am CT through 9:00 am CT on Friday September 27th, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. How to Enter.

On-Air: Listen to the Station weekdays during the Contest Period. When the Station plays the "cue-tocall", listeners must call the Station at 833-390-5723. The designated caller to the Station, as determined by the Station in its sole discretion, will have the opportunity to participate in the "Masked Singer" game. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

Winner Selection.

Each weekday between 6:00 am CT through **9:00 am CT** Tuesday September 24, 2024 through Friday September 27th, 2024, Station will give cue to call for a chance to participate in the Masked Singer game.

Jock will designate two participants. Station will play a music scramble in which each participant will be given (10) seconds to correctly identify the name of the artist of the song scramble. There will be two rounds. Participant to win the most rounds will win the prize. Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

- 4. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. - Entry Conditions and Release.
